Director's Summary

DAY CARE SERVICES POLICY

I. Intent Purpose: It is the intent of San Andreas Regional Center to fund subsidize day care assistance when an individual under the age of eighteen years of age requires specialized day care beyond what is typically expected of and in consideration of the family's obligation to provide care to a minor of that age,. The regional center shall implement this policy in compliance with all existing federal and state laws and regulations (e.g., California Welfare & Institutions Code §4512(b) and §4648(a) (6) (D), and 34 Code of Federal Regulations §§303.344 and 303.527).

Parents may choose to use Financial Management Services (FMS), or they may choose to use a vendorized agency. The Lanterman Developmental Disabilities Services Act may require the parents to participate in the Family Cost Participation Program (FCPP) or other cost-sharing measures. The Parent(s) will complete the Annual Day Care Worksheet (appended) and submit the completed form to the Regional Center in order to calculate the number of service hours needed requiring subsidy.

2. Reimbursement of Health Care Co-Payment and Co-Insurance revisions:

Health care service plan or health insurance policy refers to a type of insurance coverage
that pays for medical, behavioral, and surgical health care expenses that are incurred by
the insured. Health insurance can either reimburse the insured for expenses incurred from
illness or injury or pay the care provider directly. Most health insurance benefits, and
terms of service are applied annually.

3. Supportive Living Services revisions:

. **Definitions**:

 Consumer, individual, and person served are used interchangeably in regional center policy and the Lanterman Developmental Disabilities Services Act and mean a person who has been found eligible and receives services from the regional center. These same terms are used throughout the Lanterman Developmental Disabilities Services Act.
